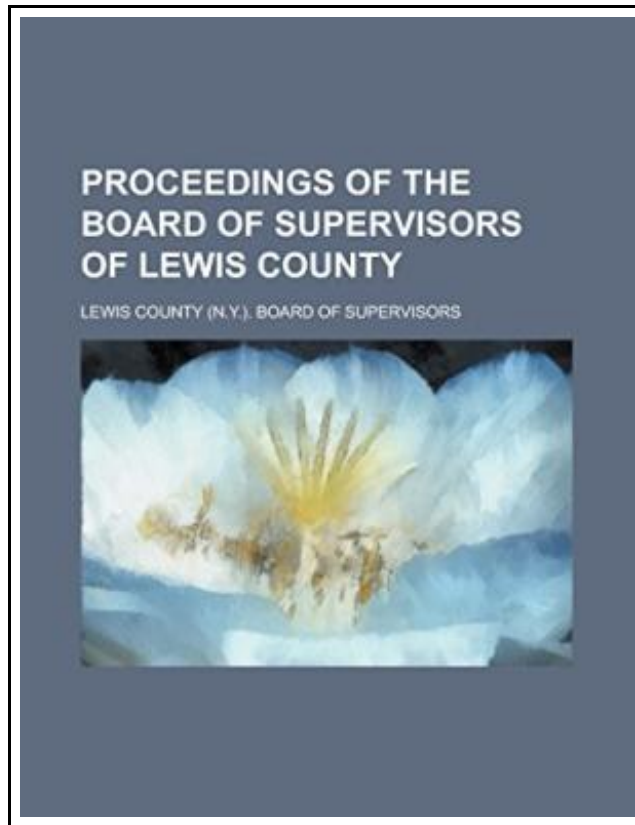

Mr. Garmon moved that the special committee proceed to open the bids they had received from the printers in relation to printing 1,500 copies of the proceedings in pamphlet form. The bids were opened and read as follows: To the Honorable Board of Supervisors: We will print 1,500 copies of the supervisors-pamphlet of proceedings for...
